NOTIFICATION:-

No. Home/COVID-19/22(iii)/2021: In continuation of Notification No. Home/COVID-19/22(iii)/2021 dated 14.04.2021, the President Azad Jammu and Kashmir, in light of decision made in the meeting of NCC held on 23.04.2021, has been pleased to accord approval for implementation of following additional/amended NPIs during the Holy Month of Ramadan to contain the COVID-19 spread

- i. All Schools/Colleges shall remain closed in districts with positivity rate more than 5% including classes from 9th-12th. Online classes shall remain continued.
 - ii. Complete ban is imposed on all activities after 6:00 pm till Sehr; however, essential services (petrol pumps, medical stores and vaccination centers etc) are exempted. Section 144 will be imposed for strict implementation of NPIs.
 - iii. Friday & Saturday shall be observed as closed days during a week; however, essential services (petrol pumps, medical stores and vaccination centers, poultry and vegetables shops etc) shall remain opened. Section 144 shall be imposed for strict implementation of NPIs.
 - iv. Complete ban shall be imposed on indoor/outdoor dining; however, take aways will be allowed.
 - v. All indoor gyms shall be closed throughout the State.
 - vi. Office timings shall be observed from 9:00 am to 2:00 pm by all public/private offices/departments.
 - vii. Strict implementation of 50% work from Home Policy shall be observed by all public/private offices/departments.
 - viii. Stringent Tourism protocols shall be implemented to curtail mobility/influx of tourists especially during Eid holidays
2. These NPIs shall be implemented forthwith and shall remain enforced till 17.05.2021.
