## **NOTIFICATION:**

No.S&GAD/R/A-4(5)2021 Part-VII. In exercise of the powers conferred by Section 23 of Azad Jammu & Kashmir Civil Servants Act, 1976. the Azad Government of the State of Jammu & Kashmir is pleased to make the following rules, namely:-

- 1. <u>Short title, Extent and Commencement.</u> (1) These Rules may be called the Azad Jammu and Kashmir Forests Officers Departmental Examination Rules, 2021.
  - (2) These shall come into force at once.

## 2. **Definitions.**-

- (i) "Competent Authority" means the appointing authority as defined in the Azad Jammu and Kashmir Civil Servants (Appointment and Conditions of Service) Rules, 1977.
- (ii) "Departmental Examination", means an examination conducted under these Rules to evaluate the professional competence and suitability of Forests Ranger BS-16 and Assistant Conservator of Forests BS-17, for promotion to the next scale/grade.
- (iii) "Examination Committee", means the Committee constituted for coordination to conduct the Departmental Examination through Kashmir Institute of Management (KIM) which shall consist of the followings:-

Secretary Forests, Wildlife, Fisheries
Chairman
Chief Conservator of Forests (Principal)
Member
Member Board of Revenue (M&E)
Conservator of Forests, Muzaffarabad
Member/Secretary

- (iv) "Misconduct", means creating a situation which may hinder the smooth conduct of the Departmental Examination, conveys verbal gesture of aggression to any Examination Committee member or any other authorized officer which is nominated by the said Committee or consciously disobeys any instructions issued by the Superintendent of the examination or his staff in the examination hall.
- (v) "Officers", means the Forests Range Officer B-16 and Assistant Conservator of Forests B-17 of Azad Jammu and Kashmir Forests Department.
- (vi) "Unfair Means", means the unauthorized carriage of any material like books notes, paper or device which can communicate any information, or verbal or gestural communication with other participant to seek or to render any information which helps in solving questions asked in paper or committing act of cheating etc.
- 3. (1) All officers shall have to pass the Departmental Examination in the following subjects except those who have already passed the examination before the commencement of these Rules and the Azad Kashmir Forest Service Departmental Rules, 1954:-
  - (a) Forest Law
  - (b) Procedure and Accounts (with books)
  - (c) Land Revenue and Demarcation
  - (d) Forest Management and Protection



- One paper shall be set on each subject, in accordance with the prescribe syllabus as appended to these Rules.
- (3) Every Officer shall have only three (3) chances (one initial chance and two consecutive Supplementary chances) to pass the examination.
- 4. Examination shall be held yearly, in the month of October at Muzaffarabad on sucdate as may be fixed by the committee.
- 5. The papers shall be set out by the committee constituted by the Director Genera Kashmir Institute of Management (KIM).
- 6. The Officers who do not qualify the Departmental Examination under these Rules shall not be considered for promotion to the next scale/grade.
- 7. Medium for examination shall be English or Urdu.
- 8. Officers over 58 years of age shall be exempted from Departmental Examination.
- 9. Any Officer found using any unfair means to answer the questions during the Departmental Examination or misbehaving with any officer conducting the Departmental Examination, shall be considered guilty of Misconduct and shall be proceeded under the prevailing disciplinary laws. The Examination Committee shall recommend punitive proceedings against those who found guilty under these Rules.
- 10. The Chief Conservator of Forests (Principal), shall initiate/process the case for punitive proceeding within 30 days from the date of recommendations by the Committee under Rule 9.
- 11. The Director General Kashmir Institute of Management (KIM) shall act as the Controller of Departmental Examination.
- 12. Appendix, paper I to IV shall be the integral part of these Rules.
- 13. Repeal.- The Azad Kashmir Forests Service Departmental Rules, 1954 are hereby repealed.
